Old Business

1. Sign Zion Bank's Safe Deposit Box Rental Agreement (All)

1. Discuss possible additional Work Session/Special Meeting

Leppanen sent an email to Chris McAnany asking if the map had to be finalized before we could vote on it. His response was we can approve a partial map if we references changes to it. The map must be final to be able to vote on land use ordinance and the subdivision ordinance. The Council agreed to finish the map and vote at a special meeting Thursday, September 5th at 4:00 p.m. Mary Gilliam will finalize the map and she worked together with the Council identifying every parcel change on the recommended P&Z I map on the wall by parcel number.

Hook spoke with gratitude to all Council members, P&Z members and citizens who have been part of the process that got us to this point. She mentioned the diversity of business and property owners, people who live in every section of town, age and career. As a property and business owner she declared Conflict of Interest. Sayers reported that legally Conflict of Interest must be declared and Leppanen advised she could step out of the room if it came up in a meeting. A person declaring Conflict of Interest can still vote in Utah.
