1. Discussion and Vote to Approve Bluff Town Council's Second Community Development Block Grant Public Hearing Minutes

It includes community information, contacts, priorities and road information. She has it ready to submit on a different form to cover all bases for the grant. Murray motioned to approve, Sosa seconded and Leppanen, Sosa, Hook, and Murray voted in favor.

5. Vote to transfer annual Class C Road payment to the Town of Bluff General
