

A RESOLUTION BY THE BLUFF TOWN COUNCIL TO AUTHORIZE A COMMITTEE FOR THE ACTIVE TRANSPORTATION PLAN AND SUBSEQUENT GRANT APPLICATIONS

WHEREAS, the Bluff Town Council has worked closely with Utah Department of Transportation on several mutually beneficial projects;

WHEREAS, over the past 4 years following incorporation, the Bluff Town Council had not had a need for development of an Active Transportation Plan;

WHEREAS, the residents of the town of Bluff have had ongoing concerns as to safe passage of vehicles, pedestrians, and bicyclists throughout the town which is bisected by State Highway 191;

WHEREAS, Luanne Hook, a Bluff Town Council Member and several residents of the town have been exploring various grant opportunities and now is the opportune time to form a committee to work on the Active Transportation Plan which will allow for various grant opportunities;

WHEREAS, Luanne Hook, Molly Schmidt, Deborah Westfall, Anthony Lott, Father Joe Hubbard, and Jim Sayers have asked to be the members appointed by the Bluff Town Council for that committee;

WHEREAS, bylaws or policies will be forthcoming for the members to review and make recommendations to the Bluff Town Council;

WHEREAS, the committee is subject to oversight and approval by the Town Council;

THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF BLUFF, UTAH:

SECTION 1. FORMATION OF AN ACTIVE TRANSPORTATION COMMITTEE APPOINTMENT AND APPOINTMENT OF MEMBERS. The Bluff Town Council hereby creates an Active Transportation Committee and appoints Luanne Hook, Molly Schmidt, Deborah Westfall, Anthony Lott, Father Joe Hubbard, and Jim Sayers as members of the Active Transportation Committee.

SECTION 2. Effective Date. This Resolution shall become effective upon passage.
