I do not know if they might not have construction requirements not being met if/unless the owner submits to FAA their proposed landing area.

The [Notice for proposed Landing Area 7480-1](#) process allows the FAA to evaluate the proposed landing area as it relates to safety of the National Airspace System. The FAA does not have local land use jurisdiction. Permitting requirements (if any) would be a local jurisdiction requirement.

Until the 7480 is received, [evaluated by various lines of business within the FAA](#), and [published by the National Flight Data Center \(NFDC\)](#) the landing area does not exist in our database. FAA has no way of identifying if there are landing areas that have not been submitted to us. The FAA does not require a public notice as part of the 7480-1 application/review process. Any public notice may be a requirement of the local planning/zoning office.
