# 1. Discussion of Certified Property Tax Rate

Leppanen explained that every year we set the tax rate. If we do not change the tax rate a Truth in Taxation hearing is not necessary. Hearing no interest to change the tax rate from the Council Leppanen declared we would keep the current tax rate. Duncan Lyman is working with the State Tax Commission and should have the tax rate by Tuesday, June 13<sup>th</sup>. We will vote to approve on next week's agenda.

### 3. Discussion of Amended FY 2023 Budget

Nelson presented the highlights of the amended budget and noted projections from last year were very close to the revenue and expenses of the actual budget. The General Fund increased from \$432,204 to \$579,365 due to increased tax revenues and the airport maintenance project. The Roads Fund needs to balance within it self and as part of the General Fund. It has a deficit of \$9,000+ because of an increase in expenditures and that will need to be covered by the General Fund. It did receive a matching grant from the San Juan County Transportation Board. She noted the new joint banking account with Utah Dine Bikeyah and the Special Revenue Fund for the CCC project. Leppanen explained the airport maintenance project cost is about \$138,000 and our cost is \$13,000 to \$14,000. There are two ways to pay it, the Council pays the whole bill and is refunded by UDOT or UDOT sends us their share and we will pay the entire

bill. We will do the latter. Leppanen proposed to hold the vote to approve the budgets until the June 13<sup>th</sup> agenda to give Council members more time to think about recent changes.

## 5. Discussion of Tentative FY 2024 Budget

Nelson explained the 2024 budget has a projected 2.5% decrease from last year based on information from Utah League of Cities and Towns on state-wide sales revenue expectations. We are working on a fee schedule and will be applying for grants. Expenditure items include Dark Skies, the CCC renovation and the solar eclipse. Roads spending is minimal, the CCC special revenue fund is added. Funds for the Fire Department and EMS are added and include fundraising money from last year's Fort fundraising breakfast. Murray said the budget was done well and it is good to be cautious. Leppanen noted if we receive more grant money it could trigger an amended budget. The budget for Fire is less than requested and includes administrative personnel, maintenance personnel and supplies. This is new for the Town and the budget is fluid in terms of increasing funds to the Fire Department.

# 6. Public Comment on Tentative FY 2024 Budget

Gary Lichtenstein, assistant fire chief, expressed appreciation to the Town for their work. He noted this is the first time the Fire Department has had a budget and it will take some stress off the volunteers and leadership. Leppanen explained it will be worked out how to administer the funding and year end report. She expressed appreciation for all of the fire volunteers.
