#### **Unfinished Business:**

- 1. Discussion of the Strategic Plan Work Session and Vote on Any Changes (All)
  The Work Session was immediately before the Regular Meeting and consensus was it was good and helpful.
- 2. Discussion of the Equal Justice Government to Government Environmental Protection Plan Work Session and Recommended Modifications (Nelson/All)

Nelson reported discussions helped clarify the budgets for current grants, exchange ideas and include other ideas. She is rewriting the budget so it is very detailed and adding to the original plan in preparation for the due date next Tuesday. March 1<sup>st</sup> is the date to sign the contract. Janet Slowman-Chee will take a copy to the Dine Bikeyah Board and the Town Attorney is drafting an agreement between the Council and Dine Bikeyah. Leppanen noted Nelson has been working really hard to prepare the plan for submission and thanked her.

## 3. Report on Bluff Planning and Zoning Commission Meeting of February 7, 2024 (Hook)

Hook reported an overview from Hanson Planning Company about the subdivision plan, and work on dirt work, RVs, signage, building permits and recommendations. The signage ordinance will be passed on to the Council. Leppanen noted there is no agreement with the County over building permits and inspections with Bluff or other towns.

#### 4. Report on Active Transportation Advisory Committee (Hook)

Hook reported Bluff has made it onto the first tier of the UDOT Grant but we are near the bottom of that list. More information will come in March. Leppanen asked for clarity about the request for letters of support for the Trail system, who they went to, how it was decided and suggested policy be worked on in a Work Session. Sosa asked for copies of letters received since they are town records and are kept.

## 5. Discussion of "Change in Use" of Town of Bluff Funds to Bluff Volunteer Fire Department as Noted by Assistant Chief Lichtenstein (Leppanen)

Leppanen reported that Assistant Chief Lichtenstein let the Council know the \$25,000 in funds from the Council were being used on purchasing equipment instead of administrative needs. She thanked Lichtenstein for the information on the pivot.

## 6. Update on School and Institutional Trust Lands and Bureau of Land Management Land Exchange (Leppanen/Nelson)

Leppanen explained the Governor withdrew the Memorandum.

#### 7. Discussion and Vote on Privacy Policy (Leppanen)
